- **Due Upon Enrollment/Intent to Participate:**
  - Complete Non-Refundable Global Engagement Application form with \$45 application fee Payable to MSUM;
    - Submit Application form, check, and completed Financial Aid Form to the School of Nursing and Healthcare Leadership, Hagen Hall 213, 1213 6th Avenue South, Moorhead, MN 56563 – **these are due upon enrollment/deposit to EF.**
  - Enroll with Education First (EF) [Healthcare and Nursing in Rome and Florence](#) - requires \$95 deposit
    - Students can pay the full amount upon enrollment, pay manually, or arrange monthly payment plans with no added interest via the EF website/application process.
    - \$100 discount is available through September 30, 2022.
  - If you are paying manually (non-monthly payment) - all travel fees are required to be paid to EF by February 1, 2023.
  - If you enroll in monthly payment plan – all travel fees are required to be paid by April 28, 2023 or 25 days before travel date. This will automatically occur if you enroll in the monthly payment plan.
